



**Release of Liability Waiver – Burntcoat Head Park**

I am aware of the risks associated with visiting Burntcoat Head Park, including but not limited to injuries to myself and, where I am bringing a minor child or children to such child or children, from high tides, tripping, slipping or falling and falling objects such as rocks and trees, which may result in injury or death. I freely assume all risks and the possibility of personal injury, death, property damage or loss resulting therefrom.

In consideration of my participation, and where I am bringing minor child or children the participation of such child or children, in \_\_\_\_\_ at Burntcoat Head Park, I agree as follows:

1. Where I am bringing a minor child or children to take responsibility for such child or children;
2. To waive any claims that I may have, or where I am bringing a minor child or children any claims such child or children may have, against the Municipality of the District of East Hants, its employees, representatives and agents (collectively the "Releasees"), associated with visiting Burntcoat Head Park;
3. To release the Releasees from any liability for any loss, damage, injury or expense that I or my next of kin may suffer, and where I am bringing a minor child or children any liability for any loss, damage injury or expense that such child or children may suffer, as a result of my, and where I am bringing a minor child or children such child or children, visiting Burntcoat Head Park, due to any cause whatsoever, including any negligence, breach of contract, breach of statutory duty of care, or breach of the *Occupiers Liability Act*, SNS 1996, c 27, on the part of the Releasees;
4. To hold harmless and indemnify the Releasees from all liability for any property damage or personal injury to any third party resulting from my, and where I am bringing a minor child or children from the child or children, visiting Burntcoat Head Park; and
5. I am aware of the risks and hazards associated with visiting Burntcoat Head Park including, but not limited to, injury or death to myself and, where I am bringing a minor child or children, injury or death to such child or children, from: tripping, slipping or falling on the ground, stairs or on or in the lighthouse and other structures; advancing and high tides; falling objects including rocks and trees falling from cliff faces and caves; and vehicles including cars, trucks and busses.

I am 18 years of age or older. I am in good health.

I have read and understood this form. I understand that by signing this form I am giving up certain legal rights that I have and, where I am bringing a minor child or children, that I am giving up certain legal rights that such child or children have. Any questions have been answered to my satisfaction.

I agree to the provisions of this Release of Liability Waiver for myself, where I am bringing a minor child or children for such child or children, and my heirs, executors, administrators and assigns, intending to be legally bound by this agreement.
